Show Jumping:

Arena: All weather sand arena

Tadpole: poles on the ground. **Green:** cross rails up to 18" **Advanced Green:** 2' - 2'3" verticles. **Beginner Novice:** 2'6-2'8 verticals and oxers. **Novice:** 2'9-2'11 verticals and oxers. **Training:** 3'-3'3 verticals and oxers. **Prelim:** 3'4-3'7 verticals and oxers.

XC: **P-**2200 m @ 520 mpm. **T-**2000 m @ 420 mpm **N-** 1600m @350mpm **BN-**1400 m @ 300 mpm. **Adv Green:** 250 mpm, **Green:** 200mpm. **Tadpole:** Not timed. All courses: Average, for horses with some experience at this level. Terrain: Excellent footing if weather is good grass turf, rolling pastures and hills.

Fees:

Horse Trial Entry: \$85 for all divisions

Combined Test Entry: \$65 for all divisions

Dressage Test Entry: \$25 per test

Stabling: \$30/stall per night, initial bedding provided, additional bedding available (very limited so email to make arrangements, first come first serve!)

Entries:

Electronic entries accepted via email or thru website. Payments may be made by credit card via PayPal or by cash/check. Current coggins must be submitted with entry and payment and before closing date or may be wait listed. Entries include \$25 non-refundable office fee. Include printed, legible, and current e-mail address on entry. All correspondence from secretary will be via email.

Refunds: Before closing date- entry & stabling less \$25 non-refundable office fee; after closing date- no refund. Scratches/Changes must be in writing via mail or email. Incomplete entries may be waitlisted. Negative coggins required within 12 months for all horses.
