RULES:

- The show will be run according to FCEC Rules.
- All riders are encouraged to wear an approved ATSM helmet however; *all riders under 18 years old must wear a helmet while mounted. Parents/Guardian are responsible to ensure helmet meets standards.*
- The show is open to the public – you do not need to be a FCEC member, however FCEC guidelines will be followed.
- Negative Coggins within twelve (12) months must be provided.
- Show management reserves the right to add, cancel or combine classes.
- IF, 3 or less in a class Youth & Adult will be combined.
- FCEC members will be issued back numbers beginning with 8000 and shall be worn by the declared horse/rider combination at all FCEC shows/sanctioned shows. With the exception of any horse/rider combination(s) that have been declared BRHF member would default to the BRHF back number.
- Goodwill and sportsmanship are essential for a fun and safe show, management reserves the right to bar any animal, exhibitor, owner, or spectator for inappropriate behavior.
- Appropriate attire is encouraged, but not required.
- Neither leadership, or any affiliate of Franklin County Equestrian Club (FCEC) nor any of its members, families, organizers, property owners, nor employees shall be held responsible for accident, damage, injury, illness or loss to the animals, personal property, exhibitors, spectators or any other persons on the show grounds.
- A two (2) minute gate call and five (5) minute tack change will be enforced.
- MUST be a member of FCEC prior to the show before points will count towards year end awards. For membership information visit: www.franklincountyequestrianclub.com.
- In case of inclement weather call contact number below prior to the show and/or check FCEC website at FranklinCountyEquestrianClub.com or FCEC's Facebook page.
- Dogs must be on a leash at all times – This is a Roanoke County Park Rule.
- Alcohol is prohibited.
- Stallions must be in controlled of an adult at all times.
- Judges decision is final.

Directions to Green Hill Equestrian Park Center:

Take I-81 to exit 137, exit right ½ mile onto Route 619 (Wildwood Road). Right at traffic light on Route 11 South (460 West & West Main Street) and go ¾ mile, turn left onto Rout 639 (Diuguids Lane) at traffic light.

ALL TRAILERS: Entrance 1 mile on right. ALL other traffic – Entrance 1 ¼ miles on right.
